Scholarship funds are paid directly to the college or university for a maximum of eight (8) semesters. Grades are required from the recipient each semester, in advance of the award.

To be considered, applicants <u>must</u> provide <u>all</u> the information requested in this application. Incomplete or false information will eliminate the applicant from consideration. Finalists will be contacted and asked to appear, in person or virtually, for an interview with members of the Rotary Club of Knoxville's Scholarship Committee.
